## HOW AN OLDER IMMIGRATION PETITION CAN MAKE IT EASIER TO APPLY FOR A GREEN CARD

Did a family member or employer ever file an immigration petition or labor certificate on your behalf? If so, was it filed on or before April 30, 2001? This petition or labor certificate could help you file for a green card more easily.

INA § 245(i) allows persons would otherwise not qualify for adjustment of status to file after submitting an additional form, evidence and paying a \$1,000.00 fee. Adjustment of status means applying for a green card from within the United States, as opposed to leaving the United States to apply for a green card at the US Embassy in the applicant's country of citizenship. INA § 245(i) is very helpful because a qualified applicant can avoid consular processing, that is, traveling abroad to their country of citizenship and being interviewed at the US Embassy. The applicant would be allowed to avoid international travel and simply be interviewed by USCIS at the closest Field Office to their home in the United States. INA §245(i) is a very helpful tool for qualified applicants to apply for a green card in a more efficient and smooth manner. An immigration attorney can help you learn if INA § 245(i) applies in your case and if you qualify for adjustment of status.
